**APPROVAL OF PROGRAM FLEXIBILITY FOR FLEX-13117**

Dear Anka Ung,

This letter is in response to the request submitted by **Rady Children's Hospital Orange County** for program flexibility for California Code of Regulations T22 DIV5 CH1 ART2-70129(d).

The alternative means of compliance with T22 DIV5 CH1 ART2-70129(d) include

Instead of posting individual letters, a current list of all approved program flexibility will be displayed next to the hospital's license. The list includes:

- Flex regulation number
- Concise detailed description of the program flexibility
- Start and end date of the program flexibility
- Written information on how the public can easily access/view the approval letters.



The list will include a QR code that directs the user to the choc.org website which allows the public and staff to easily access and view the full program flexibility approval documents electronically. The list will be maintained and updated regularly to ensure accuracy and compliance.

Your request for program flexibility of **T22 DIV5 CH1 ART2-70129(d)** is approved under the following conditions:

1. A current list of Program Flexibility approvals granted by California Department Public Health (CDPH) shall be posted adjacent to the facility's license. The list shall include the following:

- Regulation section heading and specific regulation number [i.e., Title 22, California Code of Regulations - Program Flexibility - Section Number: 70129(d)].
- A short, detailed description of the program flexibility granted by the department.
- The program flex start date and end date is specified in the approval letter.
- Written information to the public on how to easily access true copies of the approval letters granted by CDPH.
- The posted program flex summary may reference a program flex binder containing complete copies of each program flex and provide the binder's location for public viewing.

2. The Hospital must maintain a listing of all approvals electronically and in a binder to be able to produce for anyone requesting verification of a program flex.

3. The Hospital must post this approved program flex adjacent to the hospital's license to alert individuals that they may request to see a copy of program flexes in the Administration Office during business hours. After hours, individuals would be able to speak with the Operations Supervisor who would have access to this file electronically.

Either this letter or a true copy thereof shall be posted immediately adjacent to the facility's license.

This approval shall remain in effect from Jan 26, 2026 until Jan 25, 2029.

**NOTE:** The Department may revoke the program flexibility if the licensee does not comply with the conditions set forth in the approval or if the department determines the proposed alternative does not adequately meet the intent of the regulations.
